### Introduction

Leopard Imaging is committed to responsible sourcing of minerals used in our products. This policy outlines our approach to ensuring that the minerals in our supply chain are sourced ethically and without contributing to conflict, human rights abuses, or environmental degradation.

### Policy Statement

Leopard Imaging recognizes the significant responsibility of sourcing materials from conflict-affected and high-risk areas. We are committed to:

- 1. Supporting Global Efforts:** Complying with and supporting international standards for responsible mineral sourcing, including the OECD Due Diligence Guidance for Responsible Supply Chains of Minerals from Conflict-Affected and High-Risk Areas and the relevant provisions of the United States Dodd-Frank Act.
- 2. Transparency:** Ensuring transparency in our mineral sourcing practices and supply chain due diligence.
- 3. Supplier Engagement:** Working closely with our suppliers to ensure they share our commitment to ethical sourcing and are compliant with this policy.
- 4. Risk Management:** Identifying and assessing risk in the supply chain and taking appropriate action to mitigate any identified risks.
- 5. Continuous Improvement:** Regularly reviewing and improving our responsible sourcing practices.

### Due Diligence Process

To support responsible mineral sourcing, Leopard Imaging will:

- Establish strong company management systems.
- Identify and assess risk in the supply chain.
- Design and implement a strategy to respond to identified risks.
- Carry out independent third-party audits of supply chain due diligence.
- Report on supply chain due diligence.

### Supplier Code of Conduct

All suppliers to Leopard Imaging are required to adhere to our Supplier Code of Conduct, which includes requirements to:

- Conduct their operations in a socially and environmentally responsible manner.
- Ensure that products supplied to Leopard Imaging do not contain metals derived from minerals that directly or indirectly finance or benefit armed groups.
- Provide full traceability for all minerals used in products supplied to Leopard Imaging.

### Reporting and Grievance Mechanism



Leopard Imaging is committed to transparency in its approach to responsible mineral sourcing. We will report annually on our efforts in this area. Stakeholders are encouraged to report any concerns regarding the sourcing of minerals in our supply chain through our established grievance mechanism in an email.

**Review and Implementation**

This policy will be reviewed annually and updated as necessary to ensure it remains effective and relevant to our operations. Implementation of this policy is the responsibility of Leopard Imaging's senior management, with regular monitoring and reporting on progress.
